1. BETH COALTER TRIBUTE

The Vice-Chairman, Oregan Hoskins, extended a warm welcome to Jason Leonard, President of the Rugby Football Union and all the delegates on the occasion of the 12th General Assembly of World Rugby in London, England.

The Vice-Chairman started the General Assembly by noting the sudden and untimely passing of Beth Coalter, World Rugby Sevens Operations Manager.

The Vice-Chairman paid tribute to Ms Coalter noting that during her 10 years as World Rugby Sevens Operations Manager Ms Coalter was at the forefront of the hugely successful transformation of Rugby Sevens into a global, record-breaking and world-class Olympic sport.

The Vice-Chairman recalled that Ms Coalter started her career in Rugby at the Hong Kong Rugby Football Union where she worked for more than 15 years helping to secure the place of the Hong Kong Sevens as one of the most popular and successful annual sporting occasions in the world. The Vice-Chairman added that Ms Coalter was instrumental in the success of Rugby World Cup Sevens 2005 which was held in Hong Kong.

The Vice-Chairman advised the General Assembly that Ms Coalter brought her love of the Game to the global stage and that as the popularity of the Series continued to grow, Ms Coalter also played a leading role in World Rugby's campaign to return the sport to the Olympic Games by ensuring that the International Olympic Committee Executive Board saw Sevens as a wonderful addition to the summer Olympic programme.

The Vice-Chairman recalled that one of Ms Coalter's many successes came in 2009 when she led the team that ran the Rugby World Cup Sevens in Dubai. The Vice-Chairman noted it was the first time the tournament included a women's event and it captured the hearts and minds of the IOC Executive Board. The Vice-Chairman added that the IOC delegates left Dubai extremely impressed and Rugby's re-admission to the Olympics was secured not long afterwards.

The Vice-Chairman recalled that behind all of her hard-work and determination there was a wonderful, caring and loving person. He highlighted that Ms Coalter always went the extra mile for the teams and players.

The Vice-Chairman noted that many tributes had been received since Ms Coalter's death was announced from all over the world and thanked the Rugby family for showing solidarity at this difficult time.

The Vice-Chairman spoke of how Ms Coalter would be greatly missed by all who had the pleasure of working with her, both at World Rugby and in the Regions and Unions. The Vice-Chairman added that the knowledge she had passed on to others leaves the Series and the Game in a very strong place. The Vice-Chairman noted that the thoughts and prayers of the General Assembly are with her loving family and work colleagues at this very difficult time.

As a mark of respect, the General Assembly stood and observed a minute's silence in memory of Beth Coalter. As a further mark of respect, the General Assembly adjourned for ten minutes.

2. VICE-CHAIRMAN'S WELCOME

The Vice-Chairman noted that every branch of the World Rugby Family was represented with almost all of the Unions, Regional Associations, World Rugby Council and World Rugby staff in attendance. He added that the World Rugby Family had gathered during the very special and record-breaking Rugby World Cup to take stock of the Game and decide how Rugby wants to grow in the future.

The Vice-Chairman reflected on Rugby World Cup 2015 which had been an incredible, competitive and compelling, global celebration of Rugby. The Vice-Chairman highlighted that Rugby World Cup 2015 had projected Rugby and its character building values to record audiences globally engaging and inspiring new players and fans around the world to get into Rugby. He added that RWC 2015 is the biggest Rugby World Cup to date with record attendance, record television audiences while the social media reach and engagement had gone further than ever before making it one of the most talked about sports events on the planet.

The Vice-Chairman highlighted that the tournament had been the most competitive Rugby World Cup to date with the lowest average winning margin of any previous tournament and the lowest between the Tier One and Tier Two Teams. The Vice-Chairman outlined that the results reflected why World Rugby are committed to investing in competition and administrative structures and technical coaching support globally.

The Vice-Chairman applauded all of the competing Unions, not only those competing in England and Cardiff, but all the countries who had participated since qualification started in Mexico City in 2012.

The Vice-Chairman acknowledged that Rugby is at a crucial time in its development with 7.2 million men, women and children now playing the Game and unprecedented commercial success. The Vice-Chairman outlined that as World Rugby looks beyond Rugby World Cup 2015 there are fantastic opportunities to extend the growth of the Game, embrace new markets and project Rugby's values to more people. He added that following Japan's heroics during Rugby World Cup 2015, Rugby had an opportunity to ignite the Asian market, home to 60% of the world's youth, with Rugby World Cup 2019 in Japan.

The Vice-Chairman looked forward to the enormous opportunity presented Rugby's reinclusion to the Olympic Games in 2016 and 2020 where Rugby will play a central role on sport's greatest stage. The Vice-Chairman noted that inclusion in the Olympic Games had led to increased participation worldwide due to National Olympic Committee and government support. He added that in the lead up to Rio 2016, the HSBC Sevens World Series continues to go from strength to strength with an expanded Sevens World Series achieving record viewing and attendance figures and exiting new host cities joining the Series for the 2015/2016 season.

The Vice-Chairman highlighted that as Rugby grows Player Welfare will continue to be World Rugby's number one priority and that World Rugby will continue to develop its education, prevention, management and research programmes. He added that World Rugby will continue to work in collaboration with leading independent experts to protect and support players at all levels of the Game.

The Vice-Chairman noted that similar to all sports, Rugby will face challenges that accompany rapid growth in a congested sports and entertainment marketplace and encouraged all Unions to work with World Rugby to meet these challenges and maximse the opportunities ahead.

The Vice-Chairman advised the delegates that the first day of the General Assembly would consider how to further enhance player welfare, World Rugby's number one priority, the activities and role of the Regional Associations and the growth of the Game. He added the second day would review the strategic plan and the next steps required to ensure Rugby continues to captivate and flourish. The Vice-Chairman noted that day two will also consider how to ensure strong and inclusive governance is in place to provide a roadmap for the future prosperity of the sport.

The Vice-Chairman concluded that the General Assembly would be a thought provoking process and he encouraged all delegates to engage fully and devote their energies to thinking about the important agenda topics. He added the contributions of the delegates will guide the way forward to ensure that Rugby is accessible to all, inclusive, sustainable and continues to reach out to more men, women and children around the world.

3. OFFICAL OPENING OF THE 12TH WORLD RUGBY GENERAL ASSEMBLY

The Vice-Chairman, Oregan Hoskins, invited Jason Leonard, President of the Rugby Football Union to officially open the 12th World Rugby General Assembly.

Mr Leonard extended a warm welcome on behalf of the Rugby Football Union and the Rugby people of England to the delegates on the occasion of their visit to England for the World Rugby General Assembly and Rugby World Cup 2015.

Mr Leonard noted that Rugby World Cup 2015 had been the most successful Rugby World Cup ever both on and off the field. He outlined that record number of fans had attended the tournament and that many more visitors had experienced the Fanzones and festivals of Rugby. Mr Leonard highlighted that the Rugby Football Union had put in place a number of programmes to ensure a long lasting legacy from a once in a lifetime event.

Mr Leonard concluded that he was looking forward to being part of the World Rugby General Assembly and looked forward to welcoming and meeting as many of the delegates as possible during the World Rugby General Assembly.

The Chairman thanked Mr Leonard for his kind words and made a presentation to Mr Leonard as a token of appreciation of World Rugby for Mr Leonard attending the 12th World Rugby General Assembly.

4. MINUTES OF THE 11TH GENERAL ASSEMBLY

The Minutes of the 11TH General Assembly of World Rugby held in Dublin, Ireland in November 17, 2013 were received and approved. There were no matters arising.

The meeting received a presentation as set out in **APPENDIX FIVE** from Mr Steve Grainger, Rugby Football Unions Rugby Development Director, on the Rugby Football Unions Rugby World Cup 2015 Lead Up, Activation and Legacy programme.

11. MAXIMISING MAJOR EVENTS – RIO 2016 IMPACT PROGRAMME

The meeting received an update from Aurélie Lemouzy, World Rugby Development Programmes Officer and Santiago Ramallo, Regional Development Manager South America and World Rugby Rio 2016 Project Officer, on World Rugby's Rio 2016 IMPACT programmes.

12. WORKSHOP ONE – MAXIMISING MAJOR EVENTS

Following from Ms Lemouzy's and Mr Ramallo's presentation, Mr Tom Jones, Regional General Manager Americas introduced Workshop One – Maximising Major Events

13. GROWING THE GAME – MAXIMISING MAJOR EVENTS FORUM

14. PLAYER WELFARE

The meeting received a presentation as set out in **APPENDIX SEVEN** from Dr Martin Raftery, World Rugby Chief Medical Officer on Player Welfare initiatives. Dr Raftery advised the meeting that Player Welfare is World Rugby's number one priority and highlighted progress in the area of Player Welfare since the 11th General Assembly held in November 2013.

15. WORKSHOP TWO – PLAYER WELFARE

Following from Dr Martin Raftery's Player Welfare Overview, Mr Mark Harrington, World Rugby Head of Technical Services introduced Workshop Two – Player Welfare.

Mr Harrington advised the delegates the General Assembly would rotate through six key skill stations as follows:

- Concussion video exercises
- Graduated Return to play
- Concussion App
- Player Welfare resources available to Unions
- Key media messaging re: Player Welfare
- Life-saving skills

16. WORLD RUGBY PRESENTATION

Brett Gosper, CEO/Secretary General of World Rugby welcomed the delegates to the 12th World Rugby General Assembly.

Mr Gosper outlined that these are exciting times for Rugby and welcomed the opportunity to outline World Rugby's major priorities, all of which are drivers of growth during one the most competitive, compelling, inclusive and successful Rugby World Cups to date. Mr Gosper noted that Rugby World Cup 2015 had given unprecedented visibility to Rugby's character-building-values, which were brought to life by players and fans, capturing the imagination of a host nation and inspiring countless more on screens of all kinds around the world.

Mr Gosper advised that Rugby World Cup 2015 had put the Game in the global spotlight like never before and had generated unprecedented global profile and broken new records

in terms of commercial success, reach and engagement for the sport. Mr Gosper noted that Rugby World Cup 2015 was a record breaking tournament with over 2.4 million spectators attending Games, record broadcast audiences across 780 million homes in 207 countries benefiting from a strategy that has aggressively favoured free-to-air over subscription in key emerging Rugby markets.

Mr Gosper reported that the tournament had also set new standards in terms of digital engagement. He outlined that the innovative, creative and extensive use of World Rugby digital and social media platforms has been one of the tournament's many success stories with more than 200 million views of World Rugby social video content, Rugby World Cup 2015 has shown what can be achieved in terms of engaging and inspiring new audiences. Mr Gosper emphasised that World Rugby must now harness this potential to challenge established sports and entertainment products in new markets if Rugby is to become further established as a leading global sport.

Mr Gosper reminded the delegates that the General Assembly in 2009 had shaped the 2010-2020 Strategic Plan which is at the heart of World Rugby's mission to grow the Game and had proven to be a successful blueprint for prosperity and record growth. Mr Gosper advised the meeting that many of the goals set have been achieved and together with a new vibrant and inclusive brand guiding Rugby's journey of emphasis from regulation to inspiration, it is appropriate that the Strategic Plan was reviewed and Rugby recalibrated and stretched its ambitions.

Mr Gosper outlined that Rugby across the world is experiencing unprecedented growth across every continent with 7.2 million men, women and children playing Rugby across the World. He noted that global participation had doubled since 2009, surpassing World Rugby's previous goal of six million players worldwide by 2020. Mr Gosper noted that the World Rugby Get Into Rugby programme has reached more than 620,000 players in 2015 and is on target to achieve one million players ahead of the Rio 2016 Olympics.

Mr Gosper outlined that Rugby is growing in major markets such as Brazil, India, Germany, Russia and in the USA, where Rugby is now the fastest growing team sport. He noted that in Asia, which has 60 per cent of the world's youth, the playing population had grown by 33% over four years. Mr Gosper highlighted that Women's Rugby also continues to grow with 1.77 million women and girls around the world now playing the sport, making up more than 20 per cent of the total number of participants globally which exceeds the target of 400,000 by 2020.

Mr Gosper reiterated that Player Welfare remains World Rugby's number one priority and that World Rugby are leading the agenda in sport by supporting players worldwide with education, prevention and management programmes, which are research-based, driven by leading independent experts and making a difference.

Mr Gosper emphasised that through World Rugby's progressive new brand Rugby is now reaching, engaging and ultimately inspiring new audiences worldwide. He added that as a modern, dynamic and inclusive organization, Rugby was using its values to resonate not only with those who are already members of the Rugby family, but also with those outside the sport.

Mr Gosper noted that it was less than a year to go till Rugby Sevens makes its debut at Rio 2016. He added that there was no doubt Rugby's exceptional global growth has been aided by Rugby's re-inclusion in the Olympic Games, and Unions and had been able to access Olympic Solidarity funding and National Olympic Committee funding.

Mr Gosper noted that World Rugby are focused on ensuring that Rugby makes a compelling debut on and off the field to reinforce the message to the IOC that Rugby is good for the Olympics and the Olympics is good for Rugby.

In conclusion, Mr Gosper encouraged the General Assembly Delegates to take an active part in the Strategic Plan discussions that will help shape the future of our Game.

17. STRATEGIC PLAN 2010 – 2020

Steve Griffiths, World Rugby Head of Organisational Development, presented the meeting, a copy of which is set out in **APPENDIX EIGHT**, with an update on the progress of the World Rugby Strategic Plan 2010 – 2020.

18. WORKSHOP THREE – STRATEGIC PLAN 2016 – 2020

Following the presentation on progress against the World Rugby Strategic Plan to date, Mr Steve Griffiths, introduced Workshop Three – Strategic Plan 2016 – 2020

Mr Griffiths advised the delegates the General Assembly would work at their tables as facilitated workshops to consider the questions as set out in **APPENDIX NINE**. Mr Griffiths noted that the General Assembly feedback would be consolidated into a draft Strategic Plan 2016 – 2020.

19. GOVERNING THE GAME – WORLD RUGBY GOVERNANCE WORKING GROUP

Oregan Hoskins, World Rugby Vice-Chairman and Chairman of the World Rugby Governance Working Group, presented the meeting with an update of the ongoing World Rugby Governance review, a copy of which is set out in **APPENDIX TEN.** Mr. Hoskins outlined to the meeting that the review had a transparent process and the input of all Unions and Regional Associations had been considered.

20. OCEANIA MANDATORY GOVERNANCE PRINCIPLES

The meeting received a presentation as set out in **APPENDIX ELEVEN** from Brent Anderson, Oceania with regards Oceania Rugby Mandatory Governance Principles.

21. GOVERNING THE GAME PANEL
